

TEXAS GREYHOUND ASSOCIATION SCHOLARSHIP QUALIFICATION FORM

To qualify for a scholarship to any college, including community college, trade or technical school, the applicant must be a TGA Voting Member who has been such for three consecutive years prior to time of application. Any TGA Voting Member, TGA Voting Member's child or TGA Voting Member's grandchild, who meets the above qualification, may apply. Currently enrolled college and graduate students may apply. In addition, once the scholarship has been awarded, the student must maintain a cumulative grade point average (GPA) of at least **2.75** and must be enrolled full-time, in at least **12 credit hours per semester** (a total of 6 credit hours for each Summer session). Graduate students must be enrolled in at least 9 credit hours per semester (a total of 6 credit hours for each Summer session). If the student does not meet the above requirements, the scholarship shall be revoked; unless the student has evidence to prove a force majeure on his/her part. If the student shows sufficient evidence that the requirements have been met during the following semester after the revocation, the scholarship may be reinstated at the sole discretion of the TGA Board of Directors.
